

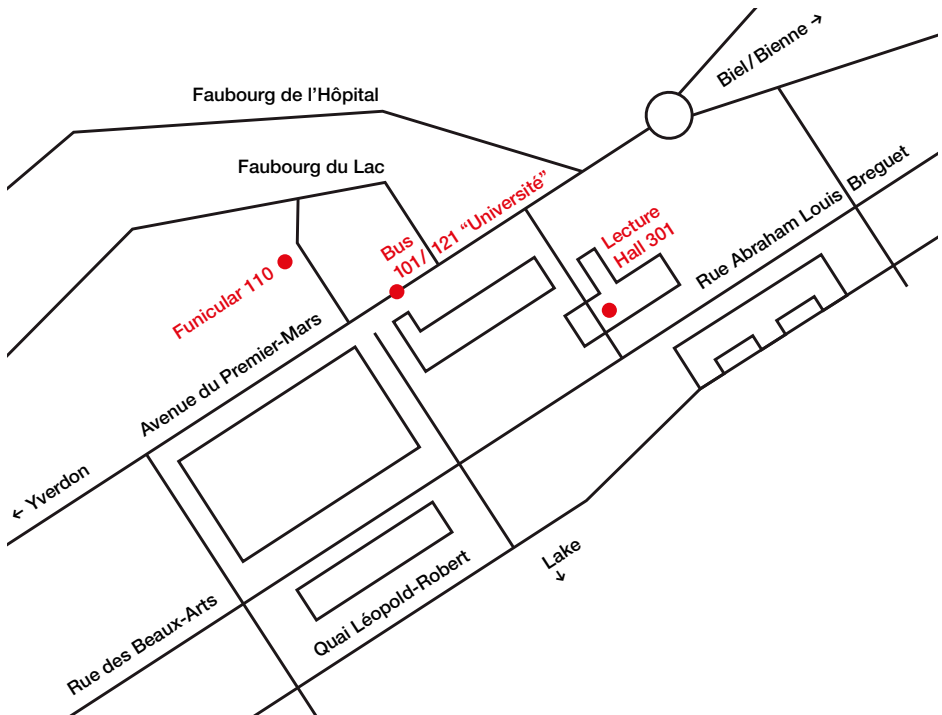

Exclusion – Discrimination – Borders. Dynamics of Inequalities in Migration Regimes

Modern societies are characterized by functional differentiations that continuously generate dynamics of inequality. These are also embedded in contemporary migration regimes, which are characterized by multiple interconnections between labor markets, legal regulations, state practices and sociocultural identities. Within such migration regimes access to political rights, to economic goods, to representation and to recognition are negotiated and distributed unevenly according to historical configurations of “race”, nationality, gender, class and other axes of difference. This Public Lecture Series assembles different disciplinary and theoretical approaches for studying dynamics of inequality in a mobile world. The interdisciplinary horizon shall open up new perspectives on the logics of exclusion, discrimination and borders in contemporary migration and mobility regimes.

The nccr – on the move is a national center of competence in research funded by the Swiss National Science Foundation. It seeks to stimulate the interdisciplinary field of migration research in Switzerland and develop new perspectives on the changing migratory reality. Managed from the University of Neuchâtel, the network comprises seventeen research teams from seven universities in Switzerland: The Universities of Neuchâtel, Basel, Bern, Fribourg, Geneva, Lausanne and Lucerne. It brings together research projects from social sciences, economics and law.
