The nccr – on the move is a national center of competence in research funded by the Swiss National Science Foundation. It seeks to stimulate the interdisciplinary field of migration research in Switzerland and develop new perspectives on the changing migratory reality. Managed from the University of Neuchâtel, the network comprises 19 research teams from eight universities in Switzerland: The Universities of Neuchâtel, Basel, Bern, Fribourg, Geneva, Lausanne, Lucerne, and Zurich. It brings together research projects from social sciences, economics and law. The nccr – on the move offers some 40 doctoral and postdoctoral fellowships to highly talented researchers in the field.
