

Core Courses #1: Reading Seminar on Migration and Mobility

The Reading Seminar is a one-day seminar part of Block 1 (Empirical Knowledge) of the Doctoral Program of the nccr – on the move. It is held in small groups of Doctoral Students who have started their contract at about the same time. It is compulsory for all enrolled Doctoral Students.

NCCR Postdocs lead the reading seminars, and the Network Office coordinates them.

The Reading Seminar addresses legal, demographic, political and historical foundations of migration and mobility in Switzerland, Europe, and the world. It also includes output from projects from Phase I of the nccr – on the move.
